In continuation to result notice dated 12.03.2008 and on rejection of candidature of Sh. Md. Nasir, Roll No. 11411146 on his failing to fulfill the eligibility criteria for admissibility of benefit of reservation in OBC category (being OBC of Rajasthan), Sh. Ajmal Saeed, S.No. 2 in the OBC category merit list of the post of TGT(Urdu) post code 114/06 whose result was kept pending for the vacancy reserved for OBC to be considered after deciding the case of Sh. Md. Nasir, is being considered in view of the Public Grievances Commission letter dated 29/07/09 and is provisionally selected and recommended for appointment to the post of TGT(Urdu) in the Directorate of Education, Govt. of NCT of Delhi in the Pay Scale of Rs 5500-9000/- (Pre-revised).

The final result under the post code had been processed as per the aggregate marks obtained by the candidates in Part I (Objective) and Part II (Descriptive) Examination held on 29.07.2007 and 02.09.2007 respectively and selection were made after determining eligibility for the post as per the Statutory RRs of the posts taking 02.02.2007 as cut off date.
